Payment Options

2 Options to choose from:

 - Submit a \$250 deposit at time of booking (Non-refundable)
 - Submit a creditcard (if different from deposit) to apply outstanding amount 7 days prior
2. Players will pay individually. No more chasing friends down for payment!
 - Organizer pays their fee upfront at time of booking (Non-refundable) and an on-line payment link will be created for you to send to your guests enabling them to pay their fees on-line. \$2.95 service fee will be added to above pricing at check-out.
 - Any fees unpaid for 7 days prior, the organizer will have the option to pay the remaining balance or release the unpaid tee times.

TERMS AND CONDITIONS

Our objective is to ensure that you and your guests enjoy your experience at Northlands GC. As with any function, a number of policies and conditions are necessary in order to protect the interest of both parties.

We ask that you carefully review the policies and conditions outlined below prior to signing the Group Booking Contract and ensure all participants are aware of these conditions. Should you have any questions or concerns in regards to the policies or conditions, we will be happy to discuss them with you.

Availability & Group Size

Groups of up to 60 players may book based on availability. **We do not offer shotgun starts.** All players will tee off the 1st hole in consecutive tee times in 9 minutes intervals.

Guaranteed Numbers

Confirmed number of players and full payment of balance owing must be received no later than 7 Days prior to your event.

Any unpaid tee times will not be held and will be released to the public. If the full payment is not received by 7 days prior, the function will be cancelled, deposit forfeited and tee times will be released to the public.

Once guaranteed numbers are received and full payment has been processed, a **maximum of 4 green fees** may be refunded and returned in the form of gift cards in the event of last minute cancellations. **Minimum 24 hour notice is required. "No-shows" on the day of your event will not be refunded.**

Health and Liquor Board Regulations

In accordance with Health and Liquor Board Regulations of British Columbia, all food and beverage shall be purchased from Northlands Bar and Grill. Staff are licensed under the Province of British Columbia's Serving It Right program. Staff members shall reserve the right to refuse service to any individual(s) who, in the opinion of the staff, have been served a sufficient number of drinks or has consumed alcohol off-site or not sold to the individual by the operator.

No Outside Alcohol is permitted on the premises and all coolers will be checked. Northlands GC reserves the right and will remove any person(s) form the course that are in breach of this regulation without a refund.

Liability

The event organizer and/or organization they represent shall be held liable for any damages not associated with normal wear and tear that may arise as a result of the actions of your event guests. Replacement value will be used as a guide to the amount payable for damages, as well as any lost revenue resulting from the damage.

Northlands Golf Course (The Corp of the District of North Vancouver) shall not be responsible for personal property or equipment brought to the site of the event, except when management of Northlands Golf Course accepts responsibility for storage and security of items delivered to the site. If items are to be placed on the golf course prior to or during your event, Northlands Golf Course (The Corp. of the District of North Vancouver) shall not be responsible for loss or damage. Management must be contacted prior to your event regarding displays, banners, signage or other items to ensure that no damage arises as a result of set-up and also for appropriateness.

Northlands Golf Course (The Corp. of the District of North Vancouver) is a municipal owned, public facility and its use of the facility should reflect this. Users of the facility shall comply with all applicable municipal by-laws and Federal and Provincial legislation, including the British Columbia Human Rights Code which prohibits discriminatory conduct including conduct that exposes any person(s) or group(s) to hatred or contempt.

Inclement Weather

Group bookings shall be played as scheduled **rain or shine** unless Management determines that the Golf Course is unplayable. In the event the golf course is deemed unplayable, we will work with you to find an alternate date, issue rain checks, or in extraordinary circumstances, issue a refund by gift card.

Power Carts

Each Power Cart must have a rental waiver signed by the operator and provide a valid credit card number as security.

*****PACE OF PLAY*****

All golfers must adhere to Northlands Pace of Play policy. Groups unable to keep to the required pace will be asked to play faster, be moved into proper position on the course or may be ask to leave the course if unwilling or unable to keep with the prescribed pace of play without a refund.

Dress Code

Proper golf attire and footwear must be worn at all times. No sandals, swimsuits, muscle shirts or cut-off shorts are permitted.

General Rules

- * Instructions from the Course Marshall and staff must be strictly adhered to.
- * Northlands staff and management has the authority to remove any player(s) who do not comply with pace of play rules or breach any of the Terms and Regulations.
- *All Golfers will be expected to keep up with the prescribed pace of play set by Northlands
- *Each player must have their own bag and set of clubs.
- *Power carts must be used in a safe manner at all times. Carts must be kept well clear of greens and tee boxes. All carts are equipped with GPS tracking to ensure that carts are used in a safe manner.
- *Maximum of 2 players per cart
- *All players must play in foursomes, unless otherwise instructed by the golf shop
- *The group organizer is responsible for the conduct of all participants and it is the group organizers responsibility to inform all their guests of the rules and ensure that these are followed at all times.

Prizing and Discounts: Group organizer receives 25% off all regular priced merchandise for your prize table. Special bulk orders can be made through our wholesalers.

Rental Clubs: Please note that we carry limited number of rental sets. Northlands cannot guarantee, nor reserve sets for specific groups where a large proportion of players require clubs. It is advised to ensure each player has their own sets.

Food and Beverage: We have a number of menu options for you to choose from to satisfy all tastes and budgets. Complete the Group Booking Form and select what you would like more information on. Reservations are required for the Bar and Grill if no pre-planned food and beverage arrangements are made in advanced. Due to other functions, regular daily golfer traffic and group events, we may not be able to accommodate your guests.
